- 1. The Candidate will provide Antiterrorism Plans management, staffing, and coordination in the development and support of the Antiterrorism Program.
- 2. The Candidate will coordinate and plan the Antiterrorism Training and Conference by assisting with the development and preparation of the Antiterrorism Conference Program material and packets for conference attendees.
- 3. The Candidate will ensure that terrorist all-source intelligence information is developed, collected, analyzed, reported, and disseminated in a timely manner throughout the MSO/CoE.
- 4. The Candidate shall coordinate meetings; prepare written comments; validate requirements; attend conferences and seminars; coordinate and plan conferences, seminars, trainings, and meetings; and staff actions in accordance with procedures as outlined in the Antiterrorism Plan.
- 5. The Candidate will support the Commanders' risk assessments to integrate threat assessments, criticality assessments, and vulnerability assessments information in order for the designated Government representative to make informed decisions to commit resources or enact policies and procedures that either mitigate the threat or define the risk.

- designated MSO/CoE Government representative to increase Antiterrorism awareness in every Soldier, civilian, and Family member.
- 7. The Candidate will provide support and initiate procedures to modify security postures derived from the Army Force Protection Condition (FPCON) System during briefings and conferences to include coordination with HQ, Department of the Army (HQDA), Major Commands (MACOMs), Major Subordinate Commands (MSCs), and other agencies or organizations (CONUS and OCONUS), observing procedures, and reporting lessons learned to Headquarter leadership.
- 8. The Candidate will establish civil and military partnerships for terrorist incident crisis by advising Government representatives and subordinated activities, which are tenants on installations and facilities, to comply with host installations and facility AT requirements. Conduct Terrorism Threat and Incident Response Planning.
- 9. The Candidate will provide technical support to track and record assessment observations and taskings using SharePoint, CVAMP, and Excel Spreadsheets used to show Antiterrorism mitigation strategies and responses to its mission; to include responding to requests for information (RFIs); staffing actions in the absence of the assigned staff officer or personnel; conducting training, when required; and reviewing and analyzing programs for content, and effectiveness and resource functions of the Protection Division.

## **Job Requirements**

Eligible candidates must be able to substantiate training and qualifications upon request.

- 1. Must possess a Top Secret Sensitive Compartment Information (TS/SCI) Security Clearance based on a Tier 5 (T5) Investigation or T5 Reinvestigation (T5R) with ICD 704 eligibility.
- 2. Must have 3-5 years of experience networking and liaison with senior staff members with the DoD and other Federal Agencies.
- 3. Must have 3-5 years of experience with serving as a security specialist to senior staff members with the DoD or other Federal Agencies.
- 4. Must have 3-5 years of experience at the Department of the Army or equivalent level working antiterrorism assessments and doctrine functions.
- 5. Must have 2-5 years of experience in researching, writing, and staffing documents and preparing and delivering presentations in support of the planning process.
- 6. Must have excellent oral, written, and presentation communication skills to brief Senior Military Leadership.
- 7. Must be qualified on Windows-based automation programs including Word, Powerpoint, Excel, Share Point, Forms Flow, and Microsoft Outlook.
